

**INFORMATION ON INTRAGROUP EXEMPTIONS**

Société Générale has submitted applications to the ACPR, relevant French regulator, in respect of the exemption from margin requirements for intragroup transactions under Article 11(11) EMIR 648/2012 and Article 20 of Commission Delegated Regulation 149/2013.
